# RFU Representative Report - Appendix 1

- 1. MJW confirmed he had yet to contact SU with regards to the Club & Community committee.
- 2. MJW commented that players representing England were paid £30k per game which he deemed a kick in the teeth to grassroots game. RTJB responded that this had been negotiated prior Covid and the players had accepted a pay cut.
- 3. HHH questioned if there had been any disciplinary actions against the Barbarians players who had broken lockdown regulations. Still to be resolved, BHS confirmed this was sub judice currently.
- 4. PD confirmed there was still £40k in the Covid emergency reserve.
- 5. MD the first of 8 cluster meetings were due to start. These would initially be to set a baseline club health check and would be carried out over a 4 week period. Initially DC, PD, HHH & MD would facilitate but the plan was for the second round to be shared amongst teams of board members. Its envisaged there would be 2-3 per season.
- 6. PD Highlighted that there is a new Sport England plan for further grants, this would include deprived areas as a priority.

# **RFU Representatives Report**

#### 6 Nations Champions 2019-20

Congratulations to England's men having won against Italy in Rome 34 -5 to become the 6 Nations Champions for the extended 2019-20 season. Peter Wheeler becomes one of the few to win the Championship as a player and as President of the RFU. Congratulations also must go to the England Red Roses for their great achievement of back to back 6 Nations Championships and Grand Slams

#### Lockdown

The Prime Minister announced new lockdown restrictions which are due to come in to force on Thursday 5 November until Wednesday 2 December.

The Government has published guidance on the new restrictions. So over the next few days the RFU will be seeking clarification on what these restrictions mean for team sports and we will provide a full update in tomorrow's Tuesday's Community Game Update. In the meantime, local restrictions apply and we remain at Stage D in the Return to Community Rugby Roadmap.

#### **Annual Report and Accounts**

Sue Day recently briefed Council on the Annual Report and Accounts. This was sent to the Game last Friday.

#### **Adult Competitive Leagues 2020-21**

The RFU Council made the difficult decision to cancel the Adult Competitive Leagues (Level 3 and below for Men, Level 2 and below for Women) for the 2020/21 season. Even if a return to full contact rugby becomes possible, playing a meaningful competitive league season resulting in promotion and relegation is no longer feasible.

The RFU have been in daily contact with Government about moving towards some form of contact rugby that will enable as many matches to take place as possible. It is important that competitive rugby is being played again and the RFU have been pushing extremely hard to accelerate a return to contact rugby. However, realising that the prevalence of Covid-19 cases in society and, given the introduction of further lockdown restrictions, negotiations continue to work with Government to create alternative solutions.

"We will do everything we can to enable the rugby community to return to contact matches as soon as we can, but our priority is to keep players, coaches, referees and volunteers safe. We will provide an update to our community clubs as soon as we can. We would like to once again thank everyone for their incredible efforts in implementing the necessary changes and for their continued support in keeping formats of rugby going during this challenging season."

# **CB Relationships Manager Team**

The CBRM team is a dedicated, focused team with the aim of ensuring a strong, effective partnership between CBs and RFU to collectively support and grow the Community game at a local level.

A team of four CB Relationship Managers, each interfacing with c. seven CBs and managing relationships across four key spheres:

- a) Between CBs and central RFU staff in the core areas of safeguarding, competitions management and discipline
- b) Between CBs and specialist RFU staff, matching CB local priorities through LRPs with relevant specialist staff (e.g. in facility development, match official growth, volunteer recruitment)
- c) Supporting co-ordination of effort between Club Developers and CB volunteers in supporting local club support.
- d) Assisting in building relationships, as appropriate, between CBs and external organisations that may be able to partner locally.

# **Structure**



#### **PURPOSE:**

Developing the community game - creating high quality experiences for players, coaches, referees and supporting clubs to support themselves in being sustainable and fit for future.

**Club Support** (Supporting clubs to support themselves) Facility Development & Operations, Club development & volunteer support

**Coaching & Refereeing** (inspiring and growing & coach & refereeing workforce) Training & development of coaches & match officials

Player Experience (Attracting new players in & keeping them playing for longer) Competitions & playing opportunities, targeted specific audiences and building a strong player pipeline in schools, colleges & universities

#### **CB Relationships Manager (CBRM):**

Team of four CB Relationship Managers, including one Senior CBRM, who will lead on cross-area work across CBs. The role will identify common areas for collaboration, as well as working with central RFU functions, in particular Safeguarding and Discipline, to develop high standards of core delivery across all CBs.

# Club & Volunteer Support Manager and Club Developers (CVSM & CDs):

Four field based teams, each comprising a Club & Volunteer Support Manager and five Club Developers. Each Club Developer will have liaison responsibilities for a group of clubs (aligned as close as possible to CB boundaries). They will work with clusters of clubs to maintain dialogue, identify issues and actively support clubs to support themselves, often connecting clubs with clubs with similar challenges/those who have overcome similar challenges.

#### **Facility Development:**

A specialist facility team, comprising a National Manager and four field based teams of two staff. They will support identified clubs with specialist facility improvement advice, manage any RFU funding support for facilities (loans/grants) and support with the securing of external funding (e.g. from local authorities or Sport England).

# **Facility Operations:**

A Facility Operations team of five staff, a National Manager along with two area based operations staff looking after the network of 28 RFU AGPs alongside a bookings administrator and sales assistant managing usage of the pitches. In addition to their core work on AGPs this team will also utilise their facility operations expertise to support clubs with facility operations and maximisation.

#### **Club Development Team:**

A Club Development team of four, all working nationally and with defined responsibilities around a) club business support (maximising financial matters such as VAT, rates, energy etc) b) volunteer training (focus on leadership development) and c) volunteer recruitment & recognition.

# **Programme Team:**

Programme Co-ordination Manager & Programme Co-ordination Executive to ensure effective and efficient co-ordination of all of the interfaces taking place with CBs, clubs and other organisations. They will also ensure appropriate matrix working across Rugby Development functional areas as well as more broadly across the organisation and with any third party organisations.

Central Support Team of four providing generic facility and programme support along with managing production of content (published, web and social) and appropriate events (e.g. Nat West Rugby Force, volunteer recognition).
