## Minutes of the last meeting.

## RFU Council Members Report.

K. Andrews provided a headline report of the Council Meeting held on 1st October. (Appendix 1)

#### Questions & Comments.

- 1. PD Concerned about the new trial tackle law for U18s which is below the waist, whilst protecting the ball carrier it could cause injury to the tackler. KA confirmed that John Lawn (RFU) had scrapped the trial for these reasons.
- 2. HHH Questioned why the County Championship competitions had not been sorted yet if go ahead to hold them had been confirmed for season 2021-2022.
- 3. DC Confirmed that the County Championship future depends on justification in terms of player & volunteer retention.
- 4. MD Received an email from Paddy Murphy at Burnley highlighting issues with GMS and the loss of a valuable volunteer due to it.
- 5. JSG Questioned what is the future for England Counties and England U20s Counties, short answer is that its unknown at the moment.
- 6. CAB Received a response from Alan Moses regarding Safeguarding Training which was to the effect of "You sort it". Very unsatisfactory.
- 7. KA There is to be a review of the RFU as a national governing body.
- 8. KA Becky Davies (Staffs) had been co-opted on Council for 2 years on the World Rugby Scholarship.

#### Disciplinary.

BHS provided a summary report of the season to date. (Appendix 1)

1. MD – Business is brisk. There have been a number of cases of underage players playing Senior Rugby. Clubs to be advised of the regulations again.

#### Team Viability.

HHH – So far this season the ADM Leagues had lost 19 games and the NOWIRUL Leagues had lost 59 games. Issues included Clubs loosing Second XVs but their Third XVs not moving up, Clubs loosing 2 Senior Mens XVs. The ADM Leagues understand they need to be flexible with Clubs. HHH to meet with Fred Swarbrick, John Powell and Matt Bryan to discuss team viability.
RFU Leagues tend to be steady as they are made up of only First XVs.

#### Red Rose Rugby.

A lengthy discussion on the Company that has been set up by the Chair of the Schools Union and how it was going about contacting people.

Companies the County use for our Schools Project had been approached by RRR and advised they were the representatives for the County.

MD – to write to RRR post KA speaking to Robbie Jones on the matter.

## The College of Rugby.

MD described the College of Rugby and how they provide BTEC Courses in Sport (Rugby Union). They are based at Sedgley Park but are not part of the club, just use their facilities. Due to the unusual set up of the College the RFU have suggested that they become a non voting member of Lancashire RFU to gain GMS access and then register with the RFU Colleges. **Membership Agreed**.

# Lancashire County RFU Summary Disciplinary Statistics Season 2021/2022

## **Notes**

# The previous season figures are based on 2019/2020. The season was incomplete I have adjusted the figures to give a full season figure.

As you can see from the total there is a 47.98% decrease in sending off cases. This is in both adult and youth matches. It is difficult to know if this improved behaviour or decrease in matches played. I suspect it is the latter.

The main surprise in statistics is the low number of tackle offences given the importance being stressed by world rugby.

For information only please do not discuss as the matters are still to be resolved. We have three matters under review. One of a club playing a player out of the correct age group which will be heard on 7 October and two allegations of racial abuse in school matches. which are being investigated by the schools under the oversight of the RFU due to the nature of the allegations.
